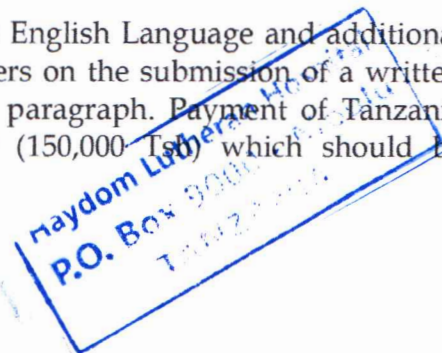

INVITATION FOR TENDERS

1. The HAYDOM LUTHERAN HOSPITAL has set aside funds from its own source and intends to apply part of the proceeds of these funds to cover eligible payments during the financial year 2023/2024. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the **Labour Charges Contract** for the Construction of **MATERNITY AND NEONATAL WARD**.
2. The Managing Medical Director of **HAYDOM LUTHERAN HOSPITAL** now invites sealed tenders from eligible building contractors registered or capable of being registered with the Contractors Registration Board (CRB) in class three (3) and above to carry out the Construction of **MATERNITY AND NEO NATAL WARD**.
3. Tendering will be conducted through the **National Competitive Tendering** specified in the Public Procurement Regulations, 2013 – Government Notice No. 446 and is open to all Tenderer as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
4. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the Secretary of the Tender Board, HAYDOM LUTHERAN HOSPITAL, P.O. Box 9000, Haydom – Mbulu, Procurement Management Unit (PMU) Office from 9:00 am to 3:30 pm on Mondays to Fridays inclusive except on public holidays.
5. A complete set of Tendering Document(s) in English Language and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under this paragraph. Payment of Tanzania shillings one hundred fifty thousand only (150,000 Tsh) which should be



deposited to the account number 0150495423204 under the name of Haydom Lutheran Hospital, at CRDB Bank.

6. All Tenders must be accompanied by a Tender Securing declaration in the format provided in Tendering document.
7. All Tenders in one original plus two copies accompanied by Tender Securing Declaration shall be filled in and enclosed in separate plain wax - sealed envelopes and marked '**original**' and '**copies**' must be properly delivered to the address: Secretary, Tender Committee P.O. Box ---9000, Haydom - Mbulu at or before **10:00 am on Wednesday 17/05/2023** clearly marked "**TENDER FOR PROPOSED CONSTRUCTION OF MATERNITY WARD TO BE BUILT AT HAYDOM LUTHERAN HOSPITAL COMPOUND.**"
8. Tenders shall be valid for a period of 90 (Ninety) days after tender opening. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening ceremony in the **HLH Conference room.**
9. Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, and Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances and will be returned unopened.
