1. The HAYDOM LUTHERAN HOSPITAL has allocated funds from its own sources and intends to use part of these funds to cover eligible payments during the financial year 2024/2025. It is intended that part of the proceeds will be used to cover eligible payment under the contract for the renovation and extension of Research Building to be built at Haydom Lutheran Hospital compound in Mbulu district - Manyara region.
2. The Executive Director of Haydom Lutheran Hospital now invites sealed tenders from eligible building contractors registered with or capable of being registered with the Contractors Registration Board (CRB) in Class two (2) and above to carry out the renovation and extension of Research Building.
3. Tendering will be conducted through the National Competitive Tendering specified in the Public Procurement Regulations of 2013.
4. Interested eligible Tenderers may obtain further information from, and inspect the Tendering Documents at the office of the Secretary of the Tender Committee, Haydom Lutheran Hospital, P.O. Box 9000, Haydom -Mbulu, PMU Office from 9:00 am to 3:30 pm on Mondays to Fridays, except on public holidays.

A complete set of Tendering Document(s) in English, along with additional sets may be purchased by interested Tenderers upon the submission of a written application to the address given in this paragraph. A non-refundable payment of 200,000/= is required payable by either Cash, or Banker's Cheque, to the Haydom Lutheran Hospital account number 0150495427500 CRDB, P.O. Box --9000, Haydom -Mbulu - Manyara.
6. All Tenders must be accompanied by a **Tender Securing declaration** in the format provided in Tendering document.

All Tenders, in one original and two copies along with the Tender Securing Declaration shall be filled in, and enclosed in separate plain wax - sealed envelopes and marked 'original' and 'copies' must be properly delivered to the address: Secretary, Tender Committee P.O. Box --9000, Haydom - Mbulu at or before 10:00 am *on Monday 25/November/2024* clearly marked ***"TENDER FOR PROPOSED RENOVATION AND EXTENSION OF RESEARCH CENTER TO BE BUILT ON PLOT No.1 AT HAYDOM TOWN, MBULU DISTRICT, MANYARA.***
